### VEHICLE MILAGE REPORT

The Lincoln exam was held on May 15th 2018 with 54 appearing and a 48% pass rate, and a second Lincoln exam was given on May 22<sup>th</sup> 2018 with 39 attending and a pass rate of 49%. The Grand Island exam was given on June 19th 2018 with 105 attending and a pass rate of 33%.

## **NEW BUSINESS**


Cory Mueller asked to look for a new meeting location, a number of locations were discussed and decided that that next meeting will be held at the Lancaster City County Building.
